## APRA BEST COUNTRY MUSIC SONG AWARD

### CONDITIONS OF ENTRY & ENTRY FORM (overleaf)

#### The Writers

- All writers (composers and authors) must be elected members of APRA - **OR** -
- Either resident in New Zealand or New Zealand citizens.

#### The Work

- The work must be an original country song. It must **not** be an arrangement or adaptation of a traditional non-copyright work or any other original work.
- The song must have been first performed in public or broadcast in New Zealand between 1<sup>st</sup> January 2009 and 31<sup>st</sup> December 2009.

#### Entries

The following will be required & must reach APRA or be postmarked **no later than 1<sup>st</sup> March**:

- Completion of an official Entry Form (overleaf)
- Individual recording of work on CD
- Lyric Sheet for the work

#### General

- Not more than **two** works may be submitted by or on behalf of any one writer. A separate entry form is to be completed for each work.
- The time, date & venue/station/channel of any one public performance/broadcast of the nominated work **must** be notified.
- Unless specifically requested, the copies of recordings submitted shall be retained by the New Zealand Country Music Awards Committee.
- It is important for the success of the awards event that finalists are available to attend & perform at the Awards Presentation on Friday June 4, 2010 at the St James Theatre, Gore. Finalists must meet travel costs (accommodation maybe provided) of attending the Awards Presentation.**
- The Award is in the form of a certificate suitably inscribed, in addition to a payment of NZ \$1,000
- In the event of more than one writer having collaborated in writing the winning work, the cash award will be allocated between the writers.
- The New Zealand Country Music Awards Committee and APRA will have the right to print the name and likenesses of any entrant in publicity in respect of the competition and all matters incidental thereto.
- Final entry is at the absolute discretion of the New Zealand Country Music Awards Committee.
- The entrant agrees to be bound by the conditions established in this entry form.
- The New Zealand Country Music Awards Committee shall have the right to interpret the above conditions and to determine all issues arising out of this contest. Any such interpretations and determinations shall be final.
- All decisions of the judges will be binding on the New Zealand Country Music Awards Committee and the entrants. The judges' decision is final. No correspondence will be entered into.
